

India to Doha

Requirements/Conditions as of 14th Jul 2021:

Passengers, who are fully vaccinated shall be exempt from the mandatory quarantine on arrival in Doha, provided that the vaccines are approved by the Ministry of Public Health (MOPH), Qatar and at least 14 days have passed after receiving the second dose (if the vaccine is two doses) or one dose (if it is a single-dose vaccine).

Requirements/Conditions:

1. Qatari Nationals, their spouses, their children, their Husbands, and companions under their sponsorship arriving with them on the same flights.

2. Passengers Holding Permanent Residency.

3. Residents arriving in Doha holding the Exceptional Return Permit.

4. Effective 01st August, Returning Resident Permit holders of Qatar can travel after obtaining an Exceptional Entry Permit to Return from Qatar Government Portal, the link provided below:

5. Visitors with personal visit visa issued by Ministry of Interior

6. All passengers returning to Qatar MUST:

- a. Install EHTERAZ app in their mobile phone.
- b. Book a quarantine hotel for one week through “Discover Qatar”, before arriving at Qatar
- c. A PCR test will be taken upon arrival in Qatar OR Passenger may carry a negative COVID-19 PCR test not less than 48 hours prior departure from an accredited Medical Centre in India.

Doha to India

Requirements/Conditions:

1. Any Indian National who has registered on the website of the Embassy of India, Doha.
 2. All passengers must submit a self-declaration form on www.newdelhairport.in and declare their consent for self-paid institutional quarantine. at least 72 hours before the scheduled arrival in India. Passengers will receive an approval code that must be presented at the Arrival Health Counter.
 3. Any passenger arriving into India and seeking exemption from institutional quarantine may apply for the same on the central website www.newdelhairport.in 72 hr before departure if they fall under any of the following five categories
 - a. Expectant mothers
 - b. Passengers with kids under 10 years of age
 - c. Patient requiring immediate medical care
 - d. Passenger with a death in the family
 - e. Passengers with COVID-negative certificate (RT-PCR) issued within 96 hrs the departure

 5. All passengers are requested to check the Country/State website before travel.
